

## **NSW Payroll Tax**

Payroll tax applies to annual payrolls of more than \$750,000 per annum and is charged at 5.45% of wages ex this threshold.

The definition of 'wages' for Payroll Tax purposes includes superannuation and payments to directors.

Various rebate schemes apply for apprentice wages, new employees and disabled workers.
